1. The Buyer is to pay a \$ \_\_\_\_\_ non-refundable deposit on the puppy. Should the Buyer decide not to purchase the puppy, the deposit will be forfeited or transferable to another litter.
2. The UKC registered name of the puppy will begin with "Krucial". Under no circumstances shall the name ever be changed on the UKC registration certificate. Subsequent owners must also agree to this entire Purchase Agreement and sign their acceptance.
3. Should the Buyer decide that he/she no longer wants the puppy/dog, they must first offer it back to the Seller before he/she can sell the dog to another party.
4. Buyer will keep Seller updated on puppy's progress and condition.
5. Buyer agrees to socialize the puppy/dog thoroughly with people and other animals. Buyer also agrees to keep said puppy healthy by providing veterinary care, and feeding a quality dog food and/or diet. Krucial Kennels recommends Blue Buffalo or Nutro Natural Choice.

6. Under no circumstances is Buyer to ever fight, roll, or face off puppy/dog with any other animal or dog. If we feel the dog is being mistreated or uncared for it will be repossessed at the Buyer's expense with no refund given.

7. Seller agrees to replace the puppy/dog if it should have a major genetic fault that interferes with the dog's quality of life, until it is 12 months old. This is provided that the puppy/dog is returned alive and in good condition to the Seller with a statement from a licensed veterinarian stating the problem. The problem/fault cannot be related to lack of nutrition, improper exercise, fighting, bad care, or unproved genetic fault.

8. If said puppy/dog is a female, buyer agrees that the dog purchased will not be bred until she is at least 16 months of age. NO EXCEPTIONS!

9. Should Buyer break this agreement in any way, ownership of the pup/dog immediately reverts back to Seller. UKC will be notified and papers will be revoked from Buyer. At Seller's option, I may confiscate the said puppy/dog immediately and without any compensation due to Buyer.

10. The undersigned Buyer and Seller acknowledge that this is a legal and binding contract and have received a signed copy.
